The program does not qualify students to practice law, sit for the state bar exam, nor act as or represent themselves as lawvers. Paralegals and legal assistants are advised to acknowledge the American Bar Association definition of a paralegal or legal assistant as "a person, qualified by education, training or work experience who is employed or retained by a lawyer, a law office, corporation, governmental agency or other entity and who performs specifically delegated substantive legal workforce which a lawyer is responsible."

NOTE: Course sequences provided on the second page are formatted to help ensure the most direct path to program completion. Deviation may add to the overall time to complete the degree, as many courses require prerequisites or are not offered every term.

Graduation:

All program requirements must be met in order to be eligible for graduation.
