

## Out-of-State Fee Waiver for Military Affiliated Students

In accordance with Florida State Statute §1009.26(13) and (14), out-of-state tuition and fees shall be waived for covered eligible individuals (Chapters 30, 31, 33, 35, 1606, 1607, and ToE, or Active Duty) **who meet any one of the following**. Please select the appropriate box below and submit this signed form along with the appropriate supporting documents to the Office of Admissions at your preferred campus location. Please note that additional documentation may be required aside from what is requested below. Honorable discharged veteran of the United States Armed Forces, the United States Reserve Forces, or the National Guard who physically resides in the state of Florida while enrolled in the institution and who is **not** receiving educational assistance from the U.S. Department of Veterans Affairs

- **Copy of DD214 Certificate of Release**
- **Proof of residing in Florida. This may include, but is not limited to a copy of Florida driver's license, Florida identification card, or a copy of a lease.**

Student who is entitled to and receiving educational assistance provided by the U.S. Department of Veterans Affairs (VA) and who physically resides in the state of Florida while enrolled in the institution. I acknowledge the waiver will not be granted in this category once VA educational assistance is exhausted or for any term I do not elect to utilize VA educational assistance

- **Copy of VA Certificate of Eligibility**
- **Proof of residing in Florida. This may include, but is not limited to, copy of Florida driver's license, Florida identification card, or a copy of lease.**

Individual using educational assistance from the U.S. Department of Veterans Affairs under Chapter 31, Veterans Readiness & Employment (VR&E) who physically resides in the state of Florida while enrolled in the institution. I acknowledge the waiver will not be granted in this category once VA educational assistance is exhausted or for any term I do not elect to utilize VA educational assistance

- **Copy of Approval Notice for VR&E Benefits**
- **Proof of residing in Florida. This may include, but is not limited to copy of Florida driver's license, Florida identification card, or a copy of lease.**

Active Duty member of the Armed Forces of the U.S. residing or stationed **outside** of the state of Florida

- **Proof of Active Duty Status**
- **Photo ID (such as Driver's License)**

By signing this form, I understand that receipt of the waiver does **not** constitute a permanent designation as a Florida Resident for tuition paying purposes and does **not** qualify me for such designation in the future. I understand that if I later seek Florida Residency classification, that I will need to reclassify and provide **three documents** under my name that are issued in Florida and **at least a year old by the start of the term that my reclassification is sought**. I understand that physical proof of Florida residency may be confirmed each semester for which the waiver is granted and that I may be required to submit documentation each semester as requested, required by Florida Statute. Students must be enrolled in a degree-seeking, or certificate program, in order to be awarded this waiver.
